PUBLIC NOTICE

All Medical Colleges/Institutes having valid Letter of Permission (LoP) for MBBS admission were directed to fill in the details/data of respective Institutions on National Medical Commission (NMC) portal for annual declaration as required in the NMC Act, 2019 and various regulations issued by NMC from time to time vide Public Notice dated 18th March, 2024 for the purpose of annual renewal of permission of UG-MBBS seats.


2. Details furnished by the college through Annual Declaration and AEBAS report of Faculties were assessed by the experts and accordingly colleges were issued notices inviting comments on deficiencies observed and also given virtual hearing to explain their point of view. Final decision was also conveyed to the colleges. In some cases, renewal of seats for the year 2024-25 granted subject to deposit of fine levied on the college keeping in view the deficiencies.

3. It is observed that few Medical Colleges/Institutes have not deposited the penalty amount as mentioned in the letter issued by UGMEB towards the renewal permission for the AY 2024-25. Counselling for admission in MBBS has already started. Due to paucity of time for exhausting the appeal process, it has been decided to grant permission for renewal for the AY 2024-25 with existing number of MBBS seats permitted for the year 2023-24. However, failure to deposit the penalty will amount to reduction of UG seats for the Academic Year 2025-26 subject to the outcome to the Appeals preferred by Medical Colleges.

4. The MBBS seats allocated to Medical Colleges by UGMEB for the AY 2024-25 is attached.

5. For establishment of Medical Colleges/ Institutions and increase of seats a separate notice would be issued shortly.

Subject: Renewal of Undergraduate Seats (MBBS) of Government Medical College, Ariyalur, Tamilnadu for the year AY- 2025-26 - regarding.

Sir/Madam,

I am directed to refer to the Public Notice issued by UGMEB vide dated 01.11.2024 uploaded on the NMC website on 06.11.2024, directing all medical colleges with valid Letters of Permission (LoP) to upload the details/data of their respective institutions on the NMC portal for the annual declaration, as required under the NMC Act, 2019 and various regulations issued by NMC from time to time, for the grant of renewal of MBBS seats for the academic year 2025-26.

2. Based on the details furnished by your college, the experts assessed the submissions, and accordingly, a Show Cause Notice dated 3rd May, 2025 was issued highlighting the following deficiencies observed during the assessment:

1. Faculty position/attendance is deficient in all the 20 departments.
2. No Cadaver is registered in 2024. All cadavers are registered in 2023.
3. Financial proofs not attached in declaration forms - Dr. Soundarrajan T., Dr. Gaodham Bharathi B., Dr. G. Sridevi, Dr. Niveditha S.
4. Lack of teaching experience for faculty appointments - Dr. P. Syanthi, Dr. Sivakumaran K., Dr. Palanichamy Priya Sharon.

3. Subsequently, the compliance report submitted by your Institution was also evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted w.r.t. your College/Institution:

1. Some of the departments are still deficient in faculty/Resident/tutor as per AEBAS record data.

Further, it has been observed that during the renewal process for the previous year AY 2024-25, penalty was imposed and conditional renewal was granted in view of the substantive nature of deficiencies in your College.

4. The Competent Authority has reviewed the Annual Declaration Report(ADR) submitted by your college/institutions and also the deficiencies pointed out by the experts. The compliance report submitted by the college has not been found to be convincing and satisfactory. To discuss the persisting deficiencies in your College, a meeting between the Secretary of Health & Medical Education/ DME of your State and Expert Sub-Committee was convened at the Commission, in the process for granting Annual Renewal of MBBS seats as per MSMER Regulation 2023 for the AY 2025-26.

5. As follow up action to the discussion held during aforesaid meeting, the Expert Sub-Committee recommended that State Government is to furnish an Assurance and detailed Action Plan to rectify the deficiencies flagged college-wise with respect to rectification of deficiencies of the Govt. Medical Colleges of the State.

6. On the receipt of requisite Assurance and detailed Action Plan in respect of your college, UGMEB has **decided to grant conditional renewal of 150 UG (MBBS) seats** for the AY 2025-26, **subject to rectification of deficiencies with in four months from the issuance of this letter.**

7. A further review will be conducted after four months, and if the deficiencies are found to persist at that time, stringent action will be initiated as mandated under Chapter III, Clause 8 of the Maintenance of Standards of Medical Education Regulations (MSMER), 2023, and any other applicable rules or regulations of the NMC.

8. If the College/Institution is not satisfied and aggrieved with the decision of the Board, you may prefer an appeal before the Commission under Section 9, Chapter IV of the Maintenance of Standards of Medical Education Regulations, 2023, (MSMER, 2023) within Sixty (60) days of the issue of this letter.
